

# SIGCOMP 2019

## Privacy Policy

Please read the following Privacy Policy carefully as it – together with the Competition Terms and the Declaration of the Participants – constitutes a binding agreement between Cursor Insight and the Participants (defined below).

Present document describes the data processing practice of Cursor Insight Hungary Kft. (seat: 1121 Budapest, Árnys út 38-40. C/4, company registration number: 01-09-276894, tax number: 25467855-2-43, „Cursor Insight” or „Controller”) in its capacity as a controller under the General Data Protection Regulation (“GDPR”) in connection with SIGCOMP 2019. Cursor Insight hereby informs participants of SIGCOMP 2019 (the “Participant” or “Participants”) that the means of the data processing are determined jointly with its British mother company, Cursor Insight Ltd. (seat: 20-22 Wenlock Road, London, N1 7GU, UK, company registration number: 08769431, „Cursor Insight Ltd.”), and consequently Cursor Insight, together with Cursor Insight Ltd qualify as joint controller under GDPR. With respect to the joint processing, present Privacy Policy is applicable to the data processing of Cursor Insight Ltd., thus the term Cursor Insight or Controller shall also mean Cursor Insight Ltd.

Cursor Insight pays increased attention to process personal data with discretion and special care, pursuant to the applicable data protection legislation and rules and in compliance with the purposes and expectations of present Privacy Policy. One of the most crucial elements of our data processing philosophy is to minimize the personal data used by Cursor Insight during the provision of our services, thus contributing to the implementation of data minimization and data security principles.

The purpose of present Privacy Policy is to properly inform the Participants of the data processing activity and practice of Cursor Insight relating to SIGCOMP 2019.

Terms concerning data protection (e.g. personal data, controller) shall have the meaning ascribed to them in GDPR and Act CXII of 2011 on the Right of Informational Self-Determination and Freedom of Information (the “Info Act”).

In addition to present Privacy Policy, Cursor Insight offers information regarding the data processing orally as well.

## 1. SCOPE, PURPOSE, LAWFULNESS (LEGAL BASIS) AND TIME OF DATA PROCESSING

Cursor Insight processes the following personal data of Participants:

In accordance with the Competition Terms, Cursor Insight will not share the Dataset (as defined later) with Participants unless they provide evidence that sharing the Dataset with them complies with Sections 44-50 of GDPR relating to the transfer of personal data. Business Participants (i) located in EU Member States may provide European Unique Identifier (EUID); (ii) located outside of EU may provide business register extract and if necessary, other document stating their compliance with GDPR, while other institutions may provide any documentation confirming their place of activity. If Participants provide personal data to evidence their compliance with GDPR and applicable data protection laws, Cursor Insight processes such personal data only to ensure the lawfulness of its processing and the legal basis of processing is compliance with a legal obligation to which the Controller is subject. Cursor Insight processes such data only until the results of SIGCOMP 2019 are published.

For the purpose of publishing an article about SIGCOMP 2019, we may collect additional personal data from Participants. The legal basis for data processing in this regard is the consent of the Participant.

Participants take full responsibility for the authenticity and validity of the information they provide to Cursor Insight and they undertake to hold Cursor Insight harmless of any claim of third persons made against Cursor Insight in the connection of the authenticity and validity of the information.

Participants may provide other personal data to Cursor Insight which are relevant to SIGCOMP 2019. The lawfulness of the processing of such data is the consent of the data subject, and Cursor Insight shall process such data for the purpose of administering the event.

The personal data of Participants who choose to be anonymous will not be used for purposes of publication.

## 2. TRANSFER OF DATA

Cursor Insight does not transfer personal data of Section 1 of present Privacy Policy to third persons, and only the name of the Participants will be published on Cursor Insight's website which is accessible by any third persons (<https://sigcomp2019.cursorinsight.com/>)

Cursor Insight does not use processors regarding personal data listed in Section 1.

## 3. RIGHTS OF PARTICIPANTS

With respect to the personal data of Section 1, data subjects are entitled to exercise all rights set out in GDPR and Info Act, including the right to access, the right of rectification, erasure, the right to restrict processing, the right to object, etc.

## 4. OBLIGATIONS OF PARTICIPANTS

Pursuant to the Competition Terms, Cursor Insight only shares the dataset (“**Dataset**”) with Participants who sign a declaration stating that they have read and accepted the Competition Terms and the Privacy Policy of SIGCOMP 2019 and who evidence that they comply with Sections 44-50 of GDPR regarding the transfer of personal data.

Cursor Insight informs the Participants that the Dataset sent to them includes the following personal data of data subjects who provided Cursor Insight with their personal data (“**Data Subject**” or “**Data Subjects**”):

- Signer ID
- Gender
- Age
- Signature and the relating biometrical data (speed, pressure, acceleration, etc. of the signature)

Participants unconditionally and irrevocably undertake to process the above personal data (i) exclusively for competing in SIGCOMP 2019 and after the results of SIGCOMP 2019 are published, exclusively for research purposes (ii) for a period until the research purposes are fulfilled, but in any case, no longer than 4 years, also (iv) with appropriate care, pursuant to the provisions of GDPR and Info Act and (v) to delete personal data immediately following the processing period.

Participants shall notify Cursor Insight of any incidents relating to personal data that happen during or after SIGCOMP 2019. Participants take full responsibility for the processing of personal data sent to them by Cursor Insight and undertake to indemnify Cursor Insight for any possible damage attributable to the processing of data by the Participants.

Without the prior written permission of Cursor Insight, the Participants shall not transfer the personal data provided to them by Cursor Insight to third persons.

The legal basis of data processing by the Participant is the explicit consent of the Data Subjects.

## 5. MISCELLANEOUS

The governing law for this Privacy Policy is Hungarian and EU law.
